With many challenges plaguing the profession, smaller firms should seriously consider looking towards merging or at the very least, the possibility of affiliating with their peers. To encourage such an initiative, the Institute has created and maintained an on-line business register, **Member Firms Mergers and Affiliations Listing**, that will encourage firms in Malaysia to seek local partners (by advertising their intention) and likewise, interested firms, will be given the opportunity to peruse through the register and identify partners that meet their profile for alliances, mergers or affiliations. The provision of this service is an extension of the services provided by the Institute under the auspices of the Public Practice Committee (PPC). This service is provided free of charge.

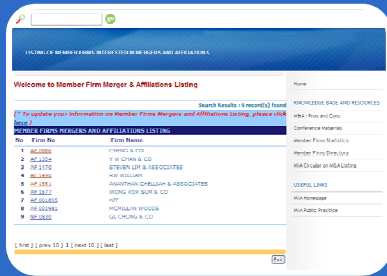

To View Member Firm Merger & Affiliation Listing



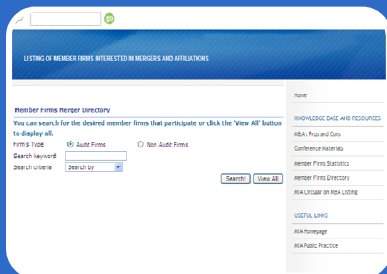
- You can view listed member firms who have indicated their interest either as potential buyers or sellers

Registration of Associated Firms

MIA By-Law 500.9 (c): if the firm is associated with any other firm of accountants, member in public practice is required to register such association whether local or overseas with the Institute within one (1) month of the association
